1. The eligibility criteria and other details are as under:

1. Executive Chef- Centaur Hotel, Delhi:

Key responsibilities:

Reporting to the GM, Centaur Hotel / Vice President-Technical/Operations. He / She will work along with the various unit's Chefs-in-charge and be responsible for the P&L of the overall kitchen operations of all the existing & future units/ F&B outlets of the Centaur Hotel. Ensures food catered in all the hotel's F&B outlets meets the highest taste, quality, hygiene & sanitization standards as well complies with all food safety regulations; generating top customer ratings leading to higher share of the business; reviews, recommends & implements the new cuisine offerings for all the outlets; initiates standardisation of recipes and creation of signature dishes across all brands; rationalizes food costs by overseeing the entire delivery chain from purchasing of raw materials to the final delivery and review of wastage; is aware of new culinary trends and recipes across multiple cuisines, including bakery & confectionary delicacies & special dietary preferences in bulk catering kitchens; creates new entrees & proactively implements menu enhancements; training & timely hiring of talent; coordinates with colleagues in Operations, Housekeeping, Engineering & HR to ensure smooth and seamless continuity of business at all times.

1. Executive Chef - Chefair, Delhi (Including two Airport Lounges):

Key responsibilities:

Reporting to the GM, Chefair-Delhi / VP-Tech/Opns. He/She will work along with the various unit's Chefs-in-charge and be responsible for the P&L of the overall kitchen operations of all the existing & future units/ F&B outlets of the Company. Ensures food catered on flights and in the Airport Lounge from the Chefair meets the highest taste, quality standard in terms of taste, portion size, hygiene & sanitisation standards as well complies with all food safety regulations; generating top customer ratings leading to higher share of the business; reviews, recommends & implements the new cuisine offerings for all the outlets; initiates` standardisation of recipes and creation of signature dishes across all brands; rationalizes food costs by overseeing the entire delivery chain from purchasing of raw materials to the final delivery and review of wastage; is aware of new culinary trends and recipes across multiple cuisines, including bakery & confectionary delicacies & special dietary preferences in bulk catering kitchens; creates new entrees & proactively recommends menu enhancements to the airlines; training & timely hiring of talent; coordinates with colleagues in Operations, Housekeeping, Engineering & HR to ensure smooth and seamless continuity of business at all times.

Academic & Professional Qualification:

Minimum of a Bachelor's degree. Those with a certification in the culinary arts from a recognized Culinary/Hotel Management Institute will be preferred.

Experience:

Minimum of **25 years** of experience in a Flight Catering/ Institutional Catering/ cruise-liner company of repute with at least **10 years** as a Sr. Chef/ Head of food production.

II. REPORTING:

- a) All positions will report to the Officer as stated above. This may, however, be changed at the discretion of the Management at any time whatsoever.
- III. <u>UPPER AGE LIMIT</u>: Upper age limit is **55 years** as on January 15, 2024. In case of reserved category, upper age limit is relaxable by 5 years to SC / ST candidates and 3 years to OBC candidates. Ex-Servicemen will be given age relaxation as per rules on the subject approved by the Govt. of India. All such relaxations would be required to produce the original certificate issued by the appropriate authority for Central Government employment.
- IV. <u>PLACE OF WORK</u>: Both the positions are based at Delhi. The nature of work and the posting can, however, be amended as per the requirement and at the sole discretion of the Company.
- V. <u>DURATION OF FIXED TERM CONTRACT</u>: Incumbent will be engaged on a Fixed Term Contract (FTC) for a period of 3 years of which he first year will be on probation. The FTC tenure can be extended or curtailed as per the Company's requirement based on your annual performance. The contract could be terminated at the discretion of the management during the period of contract without assigning any reason and / or in the event of your unsatisfactory performance.

- VI. <u>CTC / Total Emoluments</u>: During the FTC period of 3 years, the candidate will draw the monthly CTC as indicated above for the post as applicable and Statutory deductions such as PF, etc. Based on consistent exceptional performance, extension of services and CTC will be reviewed every year.
- VII. **ENTITLEMENTS**: Free meals on duty and staff discounts, as per prevailing rules of the company will be provided. Additionally, expenses incurred on any local &outstation travel for official purposes, as approved by the concerned approving authority, will be reimbursed by the Company.

VIII. SELECTION PROCESS & OTHER TERMS:

- i) Interested candidates, who fulfill the above eligibility criteria as on January 15, 2024, are required to send the completed Application Form (see prescribed format below) along with the self-attested documents in support of their candidature which must include the following:

 - b. Educational Qualification & Professional Qualification.
 - c. Experience Certificate or the Appointment Letter and Relieving Letter/ Full & Final Clearance Letter from all the previous employers.
 - d. Applicants serving in Government/ Semi-Government/ Public Sector Undertakings or Autonomous bodies may route their Applications through proper channel or along with the "No Objection Certificate" from their present employer.
 - e. Names along with email ID and Telephone/ Mobile Nos. of the reporting managers from the previous 3 organizations to be provided for Reference Checks.
 - f. Candidates are required to show their original Indian Passport (Preferably, the Passport should not be issued before 1 January 2020) and submit a self-attested photocopy of the first and last pages of the Passport. Candidate will also be required to submit a Police Verification certificate, which upon selection will have to be produced in original, prior to being appointed.
 - g. Candidates already working with Hotel Corporation of India Limited in a nonpermanent capacity and wanting to apply for any of the above mentioned posts are required to submit their applications with the written consent of the concerned Unit Head, wherever applicable, through their current Reporting Manager.
