MINIMUM ELIGIBILITY CRITERIA: (Table- 'A')

Pre-qualification criteria:

- Applicants should have experience in having successfully completed similar works of value as prescribed in Table 'A' above for Government/Semi-Government/PSUs/reputed hotels/Airport/malls/MSME/CPWD during the last 5 years ending on 31-03-2021. The information must be supported with the copies of Work Order, Satisfactory Completion Certificate, etc, proof of payment/etc.
- Applicants should have minimum average annual turnover prescribed in above table during last 5 years ending on 31st March of last financial year ie, 31.03.2021.

General Conditions:

- The application not meeting any of the above minimum eligibility criteria will summarily be rejected without further communication in this regard.
- Only one Application shall be submitted for all trade prescribed in table 'A' otherwise the application shall be disqualified without notice.
- The applicant must submit sufficient documentary evidence/work completion certificates etc. meeting the above-mentioned criteria from the Govt./Semi-Govt./PSUs/reputed MNCs during last 5 years ending on 31-03-2021(as stipulated in Table 'A').

4. The applicant should be bona-fide resourceful and well experienced contractor/agency/firm registered/empanelled with PWD/ CPWD/ RLY/PSUs/MSME/high-rise buildings/ reputed hotels/ Airport/Malls.
5. The contractor should furnish their PAN No, GST Registration details of firm etc. along with supporting documents.
6. The contractor should have a registered Office in NCT Delhi.
7. The contractor should furnish the registration details for the EPF, ESI and the Labour license details under the Labour Contract Act. Further, the selected contractors shall be bound to make payment to their workmen through their Bank account and preferably to have their Bank account for easiness of transactions.
8. The applicant applying for composite works must hold valid Electrical contractor license and supervisory license as mentioned. A-class electrical license from the Competent Government Authority issued in the name of Proprietor/Partner/Director of applied firm and should enclose photocopy thereof for verification.
9. The panel of contractors will be valid for two years and contractors will be entitled to participate at HCI work contract, Delhi.
10. For assessing the Annual Turnover of the last 3 years, contractor must submit valid documents viz copy of Income Tax Return, copies of IT assessment order, Profit & Loss Account and Audited Balance Sheet for the last 3 years.
11. The contractor shall specify the category under the trade for which they are submitting the application for empanelment. The Centaur Hotel reserves the right to accept or reject any or all the applications without assigning any reason thereof and no correspondence will be entertained in this regard.
12. The Centaur Hotel may choose to carry out physical inspection of works mentioned by the applicants in their application forms.
13. The contractors should be equipped with necessary infrastructure like office, repair & maintenance equipments, machinery and tools, labour strength etc.
14. Contractor will have to submit valid e-mail ID, cell no. and Digital Certificate to enable the firms for participation in the online procurement/e-tendering.
15. Any amendments/corrigendum for empanelment of contractors/vendors shall be published in Centaur Hotel website only. Therefore, applicants are requested to visit Centaur Hotel website regarding modifications/ corrigendum issued.
